3. To submit before the Chief Minister or the Chief Secretary, any important matter affecting the Government/public interest for his consideration/orders.
4. To exercise the functions, powers and seek protection in the conduct of enquiries in accordance with the provisions of the West Pakistan Departmental Inquiries (Powers) Act, 1958 as well as sections 4, 5, 6, 8, 9, 10 and 11 of The Sindh Tribunal of Inquiries Ordinance, 1969 in terms of Section 12 of the Ordinance *ibid*.
